**INVITATION FOR BIDS**

For Package EQ6: Axle Load Control Equipment,  
The Procurement of 7 Portable Weigh-scale System for Legal Weight Control and 7 Van Vehicles

1. The Royal Government of Cambodia (RGC) has received a financing from the Asian Development Bank (ADB) towards the cost of Rural Roads Improvement Project II and intends to apply part of the proceeds of the Loan to payments under the Contract No. MRD-RRIP II-NCB-AV-01. Bidding is open to Bidders from eligible source countries of ADB. The eligibility rules and procedures of ADB will govern the bidding process.
2. The Royal Government of Cambodia represented by the Ministry of Rural Development, now invites sealed bids from eligible and qualified bidders for Package EQ6: Axle Load Control Equipment, the supply of **7 Portable Weigh-scale System for Legal Weight Control and 7 Van Vehicles**.
3. Procurement will be conducted through the National Competitive Bidding (NCB) procedures consistent with the Financing Agreement and the Guideline for Procurement under Asian Development Bank Loans and the RGC's Procurement Manual.
4. This invitation is open to **bidders from all eligible source countries** as described in the Bidding Document,
5. Interested eligible bidders may obtain further information from and inspect the Bidding Documents at the address given below in paragraph 12, from **8:00 to 12:00 and 14:00 to 17:30 hours, Monday-Friday**
6. Qualification requirements are specified in ITB Clause 14 "Documents Establishing the Eligibility and Qualifications of the Bidder" and in Bid Data Sheet.
7. A complete set of bidding documents in English may be purchased by interested bidders on submission of a written application to the address in (paragraph 12) and upon payment of a non-refundable fee of **USD 100.00** or its equivalent in Cambodian Riel being **400,000 Riel**. The method of payment will be in cash. The bidding document will be collected in person at the discretion of bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for the purchase of the bidding documents.
8. 9. Bids must be delivered to the address given below in **paragraph 12 at or before 15:00 hours on 7 April 2020**. Late bids will be rejected. Bids will be opened in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend at the address given below in (paragraph 12) at **15:15 hours (Cambodia Time)**.
10. All bids shall be accompanied by a **Bid Securing Declaration** as described in the Instructions to Bidders.
11. The Royal Government of Cambodia (RGC) and/or the Funding Agency will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by the Government of Cambodia and/or the Funding Agency respectively, if it at any time determines that the firm has engaged in corrupt or fraudulent, coercive or collusive practices in competing for or in executing a contract.
