- **CONTRACT: PACKAGE 3-CW17d-CFAVC-MRD-KC7&8**, The Improvement of Rural Roads (14.603 km) in Kampong Cham province.
- 1. The Kingdom of Cambodia has received a loan and grant from the Asian Development Bank (ADB) toward the cost of Climate-Friendly Agribusiness Value Chains Sector Project, and it intends to apply part of the proceeds of this loan and grant to payments under the Contract for the improvement of 21.774km of rural roads (DBST/Concrete) for Lot 1: CW17c-CFAVC-MRD-TBK5 and Lot 2: CW17c-CFAVC-MRD-TBK6 and 14.603km of rural roads (DBST/Concrete) for Lot 1: CW17d-CFAVC-MRD-KC7 and Lot 2: CW17d-CFAVC-MRD-KC8.
