National Road Safety Consultant

1. The Royal Government of Cambodia (RGC) has obtained financing from the International Development Association (IDA) towards the cost of the Cambodia Southeast Asia Disaster Risk Management Project II for rehabilitation and upgrade of Rural Roads in Cambodia. The proposed PDO is to be achieved through the following components: (1) Institutional strengthening for disaster resilience at the national level; (2) Resilient rural transport infrastructure reconstruction and maintenance; (3) Project Management; and (4) Contingency Emergency Response.
2. The National Road Safety Consultant to be selected will be based in Project Management Unit, Ministry of Rural Development (PMU-MRD) and responsible to provide high quality management, monitoring and implement support to MRD on Environmental, Health and Safety aspects for effective implementation of the project. In doing so, he/she will be required to work side by side with PMU team and ESO and will develop capacity building and skill enhancement of PMU and ESO staff.
3. Minimum Key Qualifications:
  1. Must have at least a Bachelor Degree in transport engineering or civil engineering.
  2. Has more than 5 years of experience in traffic and road safety engineering schemes & implementation, community-based road safety education and training, including development and implementation of traffic and road safety schemes and management systems.
  3. Carries demonstrated knowledge of safety effect of engineering countermeasures, proper placement and use of signs, pavement markings, and roadside hardware.
  4. Highly proficient in both written and oral communication in Khmer, with good knowledge of written and spoken English.
4. Contract Duration: The National Road Safety Consultant is contracted for 12 months over the period of 48 months.

The Ministry of Rural Development invites expressions of interest from qualified and experienced candidates to undertake the above-mentioned services which are further detailed in the Terms of Reference for the assignments. The National Road Safety Consultant will be selected in accordance World Bank Procurement Regulations for Borrowers under Investment Project Financing (IPF) dated July 1, 2016, revised November 2017 and August 2018 and November 2020 (Fourth Edition)
