The Kingdom of Cambodia has received a loan and grant from the Asian Development Bank (ADB) toward the cost of Climate-Friendly Agribusiness Value Chains Sector Project, and it intends to apply part of the proceeds of this loan and grant to payments under the contract for the improvement of 29.261 km of rural roads (DBST/Concrete) for CW17c-CFAVC-MRD-TBK-1A & 2A Batch 2-Lot 1 and Lot 2.
