4	<p>I am writing to request clarification regarding a discrepancy in the Bill of Quantities concerning flat-topped humps.</p> <p><b>Identified Discrepancy:</b></p> <p>The project documentation shows conflicting quantities for flat-topped humps:</p> <ul style="list-style-type: none"><li>• <b>Document 1:</b> Shows <b>4 flat-topped humps</b> (7m x 6.5m) - Item 10: Flat-topped Hump (Code M4-05)</li><li>• <b>Document 2:</b> Shows <b>208.00 no.</b> for item 1.12.7 "Flat-Topped Hump Marking"</li></ul> <p><b>Request:</b></p> <p>Please clarify:</p> <ol style="list-style-type: none"><li>1.The correct quantity should be <b>4 flat-topped humps</b>, not 208</li><li>2.Whether item 1.12.7 refers to road markings for the 4 humps or a separate item</li><li>3.Please provide a revised BOQ with consistent quantities</li></ol> <p>This discrepancy affects cost estimation, procurement planning, and project deliverables.</p>	<p>The Employer makes available the corrected Bills of Quantities (BoQ) with reference to ITB 7.1.
